Public comments on the agenda items: Question if costs of continuing education for plumbing inspector would be shared by other offices he also serves. Request of explanation of building administration and inspection pay.

Approve agenda: Motion made by Mr. Gunnell to approve agenda. Ms. Zenker seconded motion. Motion carried 4 to 0.

Approve Consent Agenda: Motion made by Mr. Straub to approve consent agenda. Seconded by Ms. Zenker. Motion carried 4 to 0.

Committee Reports

Cedar Springs Public Library – None.

Cedar Springs Parks & Rec – Ms. Zenker reports that the Daddy Daughter Dance doubled in attendance this year. A Miranda Park Party (TV 8 personality) has been secured for July 17. Attendance has been between 3,000 and 5,000 people for this event in other communities.

Motion by Mr. Straub to authorize \$270 for MAYDAY training of 9 firefighters. Seconded by Mr. Gunnell. Motion carried 4 to 0.

Motion by Ms. Zenker to authorize repairs of fire department grass fire rig unit 2780 not to exceed \$1,150.00. Seconded by Mr. Gunnell. Motion carried 4 to 0.

Motion by Mr. Straub to authorize repairs of electrical service in fire department not to exceed \$500.00. Seconded by Ms. Zenker. Motion carried 4 to 0.

Motion by Ms. Zenker to authorize purchase of medical supplies for fire department not to exceed \$900.00. Seconded by Mr. Straub. Motion carried 4 to 0.

Motion by Mr. Gunnell to authorize purchase of miscellaneous fire fighting supplies for fire department not to exceed \$2,500.00. Seconded by Ms. Zenker. Motion carried 4 to 0.

Motion by Ms. Zenker to authorize purchase of turnout gear for fire department not to exceed \$6,200.00. Seconded by Mr. Gunnell. Motion carried 4 to 0.

Motion by Ms. Zenker to authorize purchase of fire department office chair not to exceed \$100.00. Seconded by Mr. Ellick. Motion carried 4 to 0.

Motion by Ms. Zenker to authorize purchase of heavy-duty shredder not to exceed \$450.00 from Township Administration budget and to be centrally located. Seconded by Mr. Gunnell. Motion carried 4 to 0.

Motion by Mr. Gunnell to approve pay rate of Building Administrator and Building Inspector changed to: 5% of all plumbing, electrical, mechanical and building inspection fees paid to the Building Administrator. Also, 80% of building inspection fees divided as: \$500 per month paid to the Building Administrator and the balance to the Building Inspector. Effective as of March 1, 2008. Seconded by Ms. Zenker. Motion carried 4 to 0.

Motion by Mr. Straub to approve proposal of remaining balance of Community Block Grant Funds after Arbor Circle and Hope Network to be used for road improvement. Seconded by Ms. Zenker. Motion carried 4 to 0.

Motion by Ms. Zenker to authorize purchase of water tank for grass rig for fire department not to exceed \$425.00. Seconded by Mr. Gunnell. Motion carried 4 to 0.

Motion by Ms. Zenker to authorize purchase of study books for Company Officers for fire department not to exceed \$250.00. Seconded by Mr. Straub. Motion carried 4 to 0.

Motion by Mr. Ellick to authorize \$325.00 for Continuing Education Seminar for plumbing inspector. Seconded by Ms. Zenker. Motion carried 4 to 0.

Motion by Mr. Straub to rescind duplicate transfer of funds of \$20,000 from fire fund. Seconded by Mr. Gunnell. Motion carried 4 to 0.

Motion by Mr. Gunnell to rescind early reappointments of S. Hegedus & H. Zenker to Library Board. Seconded by Mr. Straub. Motion carried 4 to 0.

Motion by Mr. Straub to approve the Resolution Opposing the Relocation of the 63rd District 1st Division Court. Seconded by Ms. Zenker. Roll call vote:
